1 immense importance to the civil rights of certain 2 religious and ethnic communities in this country, I 3 would stipulate that Mr. Eastman did challenge whether 4 we even had the authority to do it. But I would argue 5 that part of what our mission has been since the inception of the Commission, indeed, the very nature 6 7 of why this Commission was created, was to challenge preconceived notions of what allowable 8 was 9 jurisdiction and what allowable for this was Commission to go into. 10

This Commission went into the issue of 11 12 gender and equality prior to the time that Congress 13 amended the statute to include women as part of the charter of this Commission. This is something that is 14 part of who we are as a body and why our importance is 15 16 one that should still be relevant today, which you 17 know, by actions like these, tend to undermine what our role really is. 18

I am disappointed that the Commission would not even -- we have done, as far as I can tell -- we usually do reports that have findings and recommendations. This report has none. It is simply only A.

1 CHAIRMAN REYNOLDS: Okay. On October 2 22nd, 2009, the U.S. Commission on Civil Rights sent a letter to the Chief Executive Office of the Judiciary 3 4 Commission on Louisiana concerning the refusal of a 5 parish justice of the peace to issue marriage licenses 6 to interracial couples. In that letter, we requested 7 the Louisiana Judiciary Commission notify us if it was going to conduct an investigation to determine if 8 9 violations of the law or local ethics rules had 10 occurred, whether any member of the judiciary or Bar were aware of this conduct, whether there was a duty 11 12 to report the conduct to the appropriate authorities, and whether any corrective actions had been taken or 13 14 sanctions imposed.

15 We received a response on December 4th, 16 2009 included in meeting binder that was the 17 Commissioners received in preparation for this business meeting. In the response, the Assistant 18 19 Counsel states that since the Justice of the Peace resigned his judicial office, effective November 3rd, 20 21 2009, the Judiciary Commission no longer has jurisdiction over the matter. 22

But things tend to move pretty slowly around here. I think it's time to take this step and move from there. I'm hoping that we will actually get cooperation out of them after this.
