2 (9:33 a.m.) 3 CHAIRMAN CASTRO: Good morning. The meeting will come to order. It is 9:33 a.m. on June 4 5 14th, 2013. This is a meeting of the U.S. Commission on Civil Rights. This meeting is taking 6 place at our headquarters at 1331 Pennsylvania 7 8 Avenue. I'm Chairman Marty Castro. 9 The Commissioners who are present here in the meeting room with me are Commissioner 10 11 Achtenberg, Commissioner Gaziano, Commissioner 12 Heriot and Commissioner Kladney. Commissioner Kirsanow, Commissioner 13 Yaki and Vice Chair Thernstrom are participating by phone. Are you all 14 15 there? 16 COMMISSIONER YAKI: Yes. 17 COMMISSIONER KIRSANOW: Kirsanow here. VICE CHAIR THERNSTROM: 18 Here. 19 CHAIRMAN CASTRO: Okay, great. So a 20 quorum is present. Is the court reporter present? 21 He raised his hand acknowledging that. 22 Is our Staff Director present? 23 MS. DUNSTON: Present. 24 CHAIRMAN CASTRO: Great. The meeting 25 shall now come to order. Actually, before we move

2	Day. I don't know if you all knew that, but it is.
3	And in honor of Flag Day, I wanted to have us start
4	the meeting with the National Anthem. So, if folks
5	could please rise?
б	(Whereupon, a recording of the National
7	Anthem was played.)
8	CHAIRMAN CASTRO: Thank you. That's
9	right, let the games begin.
10	COMMISSIONER YAKI: I didn't know we
11	were moving to the Verizon Center.
12	CHAIRMAN CASTRO: I know. Obviously I
13	played that because it's Flag Day, and it's good to
14	have the U.S. Commission on Civil Rights begin that
15	with our National Anthem, but also despite that
16	beautiful song by a 10 year-old American of Mexican
17	descent, it did generate a lot of negative comments
18	about his ethnicity, his race, his immigration
19	status. But I know the overwhelming number of
20	Americans, like everyone in this room, were very
21	proud of that. So I just wanted to share that and
22	celebrate Flag Day with that little boy's rendition
23	of our National Anthem.
24	VICE CHAIR THERNSTROM: Well, it was
25	very nice, Marty.

1 CHAIRMAN CASTRO: Madam Vice Chair? VICE CHAIR THERNSTROM: 2 I just said it 3 was very nice. CHAIRMAN CASTRO: Well, thank you. 4 So 5 the first item thereafter is the approval of the Agenda. 6 7 I. Approval of Agenda 8 CHAIRMAN CASTRO: I know we have some 9 motions to amend. So let me move for the Approval of the Agenda. Is there a second? Do we have any 10 11 amendments? 12 You need to -- we have our new mics, so 13 I think you need to touch the button to start them. 14 COMMISSIONER ACHTENBERG: Okay. How 15 about that? CHAIRMAN CASTRO: 16 Can we hear her? 17 Good. 18 COMMISSIONER ACHTENBERG: Okay. Mr. Chairman, on behalf of --19 20 COMMISSIONER YAKI: Actually, your mics are all very live, just to let you know. 21 22 CHAIRMAN CASTRO: Okay. 23 COMMISSIONER ACHTENBERG: -- our now-24 defunct subcommittee, but as a piece of old 25 business, I'd like to move that we pull from

1 consideration the New York SAC and the Kentucky SAC 2 for very good reasons, Mr. Chairman. We will be in a position to consider them and hopefully ratify 3 them finally at the next meeting. We just are 4 5 awaiting the resolution of a few more issues before those two packages will 6 be ready for final consideration. 7 8 So I'd like to remove them from the Agenda this time, and I would refer to my colleague. 9

10 COMMISSIONER HERIOT: I would like to 11 second that motion.

12 CHAIRMAN CASTRO: Okay. So we have a 13 motion to amend the agenda. Shall we vote on the 14 motion?

So we have with us today three 12 interns -- two of the three? No, we have three 13 interns, yes, serving in our Eastern Regional Two are also going to be working in our 14 Office. 15 Midwestern Regional Office, although they're not here today. And one who is going to be in our 16 Office of General Counsel, and also one in our 17 Office of Civil Rights Evaluation. 18

19 So joining us here today are Eastern 20 Regional Office, is Frank Berdell here? No, he's 21 not here today. But he's a Government major at the 22 University of Virginia. Gracie Fernandez? There's 23 Gracie. She's a Social Work major from Rutgers 24 University. Khadijah McElroy. Khadijah earned her 25 B.S. in Criminal Justice from Rutgers as well. And

1 assisting our Midwest Regional Office is Elizabeth 2 Keller, a rising 3rd year law student from Chicago-3 Taheera Randolph, a rising 3rd year law Kent. student from LSU. Paul M. Herbert -- no, she's from 4 5 the LSU Paul M. Herbert Law Center. Paul M. Herbert is not an intern. Brenda Long will be working in 6 General Counsel 7 Office of here our at the 8 Headquarters, and Ms. Long is a 3rd year student at 9 George Mason Law School in the fall. And Ms. Amy Fischer, who will be a junior at Cornell this fall, 10 11 will be contributing her efforts to our Office of 12 Civil Rights Evaluation. She's here with us. And they're all working on interesting projects, which 13 are going to end up on our desks, hopefully soon. 14

15 So on behalf of the entire Commission, I 16 just want to welcome you and extend to you our 17 thanks for being part of our team this summer. 18 Thank you.

19 (Applause.)

20 CHAIRMAN CASTRO: Now, we have a team 21 member that's leaving us. Is Vanessa Eisemann here? 22 Today is her last day at the Commission, and I want 23 to extend on behalf of all the Commission, if I can 24 speak on behalf of all of us -- and I know on this I 25 can -- to thank you for all of the excellent work that you've done for us these last -- I guess it's been about a year now, hasn't it? And we will miss you. Your work here has had a positive and important impact, and I know that you're going on to another federal agency to do the same. So thank you, Vanessa.

7 (Applause.)

8 CHAIRMAN CASTRO: And as you know, at the last meeting we announced that the President had 9 made an appointment and we had concurred, and now 10 11 OPM has actually signed off on all the paperwork, so 12 we have our official Staff Director, after two years of waiting, Marlene Sallo, who is now sitting here 13 at my right hand. So welcome in your official 14 15 capacity for the first time today.

16 (Applause.)

17 CHAIRMAN CASTRO: We're now going to go 18 to the first item on the Agenda on Program Planning, 19 and that is to continue our discussion and make a 20 decision that we started on May 31st in terms of 21 what will be our 2014 Statutory Enforcement Report 22 topic.

23 II. Program Planning

Discussion and Vote on Ranking of Concept Paper
 Topics for the 2014 Statutory Enforcement Report

1 CHAIRMAN CASTRO: As you know, we had a 2 number of topics that we began to discuss and review 3 last month, and I understand that there is a motion 4 on both the Statutory Enforcement Report, as well as 5 one briefing for this coming year. Who would like 6 to make that motion?

7 COMMISSIONER HERIOT: I think Roberta
8 was going to make it.

9 CHAIRMAN CASTRO: Okay. The Chair 10 recognizes Commissioner Achtenberg.

11 COMMISSIONER ACHTENBERG: Yes, Mr. 12 Chairman. I'd like to move that the Narcotics Policing Report be made the Statutory Report, and 13 that the Briefing Topic entitled "Enforcing the 14 15 Americans With Disabilities Act Online" be scheduled as a hearing topic --16

17 CHAIRMAN CASTRO: A briefing topic?
18 COMMISSIONER ACHTENBERG: I beg your
19 pardon, a briefing topic.

20 CHAIRMAN CASTRO: Okay. Is there a 21 second on that motion?

22 COMMISSIONER HERIOT: I second that.

CHAIRMAN CASTRO: Any discussion? Is
there a motion to call the question? Oh,
Commissioner Gaziano wants to say something.

1 COMMISSIONER GAZIANO: I just suppose I 2 think that is a reasonable compromise, since it 3 seems to have -- I'm anticipating a majority of the Commission. But I did want to say, before we take 4 5 the vote, that I was very interested in a number of the other topics. So if this is what we end up 6 settling on, I wanted to thank other Commissioners 7 8 who took the time to write concept papers. And this 9 wasn't even my favorite Kladney.

CHAIRMAN CASTRO: It wasn't Kladney's
 favorite Kladney one, either.

12 (Laughter.)

13 COMMISSIONER GAZIANO: Which is understandable, you know? You don't get to one -- I 14 15 helped cosponsor a program on the 50th anniversary Gideon, for example, with 16 of the National Association of Criminal Defense Lawyers, and share a 17 great interest in that topic, for example. 18 I'm not it would have fit in 19 sure how within our 20 jurisdiction, but I'm sure we could have -- that was 21 my only concern with that one. Well, sometimes fake 22 shoehorning doesn't work as well. But anyway, there 23 were several very interesting topics.

24 There were also one or two others that I 25 hope further accommodations we can work out, so that

1 we can maybe come to other understandings on other 2 briefing topics, others that were recommended by 3 sort of both sides of our ideological, or many 4 sides, of our ideological spectrum. So I hope that 5 whatever agreement we reach today can bode well for 6 similar agreements on other topics.

7 CHAIRMAN CASTRO: We certainly intend at some point later on in the life of this Commission 8 and in the next few months to begin to look at what 9 briefing topics we're going to have for 10 the 11 following months, and at that time I'm sure 12 Commissioners will not only renew some of these topics, but come up with others. I know some of 13 these topics have been looked at even last year, so 14 15 these will remain in the hopper as we begin to explore that. But we won't deal with those issues 16 17 today. But I appreciate your making that point. 18 Any other comments?

19 VICE CHAIR THERNSTROM: Mr. Chairman, I20 have a question.

21 CHAIRMAN CASTRO: Yes, ma'am?

VICE CHAIR THERNSTROM: So we all voted.
We rank ordered these topics. What happens to
those votes?

25 CHAIRMAN CASTRO: Well, as we did last

1 year, it was used primarily to guide the discussion 2 at this meeting. Because initially when I first 3 became chair, there was a question as to which of these do we begin to vote on first. And so it was 4 5 decided that we would rank them and use the ranking to help guide our discussion at the meeting that 6 7 would decide it. The ranking itself was not the 8 decision on what would happen, and I believe even 9 last year the highest ranked one may not have actually ended up being chosen, ultimately, as the 10 11 Statutory Enforcement Report. So it really is a 12 guide to help us with the discussion.

13 VICE CHAIR THERNSTROM: And so you're 14 not going to report to us -- this is really not a 15 hostile question, but it's a question.

16 CHAIRMAN CASTRO: I'm sorry. I thought 17 that --

18 VICE CHAIR THERNSTROM: You're not going 19 to report to us what the ranking votes ended up 20 being, and how these were ranked?

21 CHAIRMAN CASTRO: I apologize. I 22 thought our Staff Director had circulated this last 23 night after the vote. I know I have a copy, because 24 it was --

25 VICE CHAIR THERNSTROM: I don't have

1 anything. 2 CHAIRMAN CASTRO: Okay. that Was 3 circulated, Madam Staff Director? MS. SALLO: No. 4 5 CHAIRMAN CASTRO: Okay. I have a copy here, then. I apologize. 6 Maybe we can -- can someone email this to the other Commissioners? 7 8 VICE CHAIR THERNSTROM: I don't have it. 9 CHAIRMAN CASTRO: I can tell you right now, if you'd like to know. I will -- let's see. 10 So Assessing Compliance with Section 342 of the 11 12 Dodd-Frank was ranked follows by as various Commissioners without names. 13 Someone ranked it number 10, number 8, number 12, number 5, number 7, 14 15 number 6, number 7. It did not obtain a final rank. I think only the top three got ranked. So I can 16 actually -- let me read you the top three, I guess. 17 MS. SALLO: There were ties. 18 19 CHAIRMAN CASTRO: There were ties, okay.

20 So first place was Identifying and Remedying 21 Discrimination Against Asian-Americans in University 22 and Professional Schools. That had three votes for 23 first place. And two votes for first place came for 24 Narcotics Policing, as well as two votes for second 25 place. Gideon had two votes for second place, Felon Do not quote or rely on this uncorrected transcript without obtaining written permission from the U.S. Commission on Civil Rights at transcripts@usccr.gov. 1 Disenfranchisement had two votes for third place. 2 Religious Discrimination by the Federal Government 3 had two votes for second place. OCR and DOJ's Enforcement of Sexual Harassment Law at Colleges and 4 5 Universities had two votes for third. And Enforcing the Americans With Disabilities Act Online had two 6 votes for second. 7 8 VICE CHAIR THERNSTROM: Thank you very 9 much. 10 CHAIRMAN CASTRO: You're welcome. 11 VICE CHAIR THERNSTROM: And I would love 12 a copy of that. CHAIRMAN CASTRO: We'll make sure that 13 gets to you. I apologize for that. 14 15 VICE CHAIR THERNSTROM: If the Staff Director could just send it to Tim Fay, I will get 16 17 it. 18 CHAIRMAN CASTRO: Okay. 19 MS. SALLO: I will do so. 20 CHAIRMAN CASTRO: Okay. So we have a 21 motion and a second. Any other discussion? 22 (No response.) 23 CHAIRMAN CASTRO: If not, I'm going to 24 call the question. Vice Chair Thernstrom, how do 25 you vote?

I haven't decided what my 11 12 position is. Okay, so I'll come 13 CHAIRMAN CASTRO: back to you. Commissioner Kirsanow, how do you 14 15 vote? COMMISSIONER KIRSANOW: I vote yes. 16 CHAIRMAN CASTRO: Commissioner Heriot, 17 18 how do you vote? 19 COMMISSIONER HERIOT: Yes. 20 CHAIRMAN CASTRO: Commissioner Gaziano, 21 how do you vote? 22 COMMISSIONER GAZIANO: Yes. 23 Commissioner CHAIRMAN CASTRO: 24 Achtenberg, how do you vote? 25 COMMISSIONER ACHTENBERG: Yes.

CHAIRMAN CASTRO: Commissioner Kladney, 4 5 how do you vote? 6 COMMISSIONER KLADNEY: Yes. 7 CHAIRMAN CASTRO: And I vote yes. Madam 8 Vice Chair? 9 VICE CHAIR THERNSTROM: I'll vote yes. 10 CHAIRMAN CASTRO: Okay, it's unanimous. 11 Great. Thank you all. 12 The next item agenda is on our Management and Operations. 13 III. Management and Operations 14 15 Consideration of Changes to Business Meeting 16 Calendar for August 2013 At the last meeting, 17 CHAIRMAN CASTRO: September meeting 18 we had changed the date to September 27th, at my request, because I'll be out 19 of the country, and I appreciate folks' indulgence 20 21 on that. We also left to today the discussion of 22 whether or not we would have an August meeting, 23 which is currently set for the 16th of that month, I also understand that Commissioner Heriot 24 but 25 wanted to raise an issue regarding timing of

surreplies, because we changed the September
 meeting.

3 So, why don't we sort of talk about that 4 all right now?

5 COMMISSIONER HERIOT: My understanding is that, as a result of moving the date of the 6 September meeting, if surrebuttals are necessary in 7 the Criminal Background Check Report, which we are 8 planning on voting on in September, as I understand 9 it, it will go past the date of the expiration of 10 some of the Commissioners. Now, usually we don't 11 12 need surrebuttals, and I'm hoping we won't need them in this case either, but just in case I'd like an 13 understanding that, as a result of moving the 14 15 meeting, it will be possible to get those surrebuttals in and still be on time. 16

17 CHAIRMAN CASTRO: And I had no issue 18 with that. I don't know if other Commissioners are 19 comfortable with that?

20 COMMISSIONER GAZIANO: Let me just ask -21 -

22 CHAIRMAN CASTRO: Sure.

COMMISSIONER GAZIANO: Let me just ask a
question of both Commissioner Heriot and the other
Commissioners, I suppose.

1 Would your preference, Commissioner 2 Heriot, be -- as well as the rest of the Commission 3 -- that if a surrebuttal were needed, that the timeframe wouldn't be compressed for them, but that 4 5 they would be accepted after a Commissioner's term expired, if that Commissioner submitted, say, an 6 original or rebuttal statement? 7 Or would your 8 thought to solve this issue be to compress somewhat the times to allow the surrebuttal to be in before 9 10 some of our terms expired?

11 COMMISSIONER HERIOT: I guess my 12 preference would be to not compress, and to just let 13 them be submitted after the dates of the expiration. 14 But I'm willing, if anybody feels strongly on a 15 direction --

16 COMMISSIONER YAKI: This is Commissioner
17 Yaki.

18 CHAIRMAN CASTRO: Hello, Commissioner.
19 COMMISSIONER YAKI: If I recall, and I
20 may not recall correctly, I was not allowed to
21 submit something after my Commissioner term has
22 expired.

CHAIRMAN CASTRO: Yes, my concern was
going to be letting anyone do something after their
term expires. So if we could compress the time, I

think that would be best, and the details of how we do that can be handled with our staff director. But I think, if there's a general understanding I don't know if we need to vote on that, and if we need to vote on it, we'll have a motion. But without a date, maybe we just --

7 (Off-mic comments.)

8 CHAIRMAN CASTRO: Oh, that's me. You 9 know what, I accidentally muted you. I have a 10 special mic here.

COMMISSIONER GAZIANO: The Chairman has
 power, ladies and gentlemen.

13 CHAIRMAN CASTRO: Finally I have power,
14 beyond just this gavel. There's ejection seats as
15 well, so I'll just give you early warning on that.

16 COMMISSIONER KIRSANOW: I want that17 power, too. Give it to me. Especially on Todd.

18 COMMISSIONER GAZIANO: Anyway, I don't 19 think we need to vote on that. And while we may be 20 able to make an exception to an exception, it may be 21 cleaner. But as long as we have kind of a general 22 understanding, a willingness to do that, then I'm 23 fine.

24 CHAIRMAN CASTRO: Okay. Great.25 So then in terms of the August meeting,

1 what do folks think? I know we've had brief 2 conversations about this at a couple of our 3 meetings, but we -- since it is June, we need to decide whether we're going to move forward with an 4 5 August meeting. I think we need to, but I want, obviously, to give the Commissioners an opportunity 6 to discuss that. And I'll go with the will of the 7 8 majority.

9 COMMISSIONER HERIOT: My preference is 10 to have a meeting, because we've got lots of work we 11 haven't done. We need to get SACs chartered, 12 something may go wrong with the enforcement report, 13 and so that's my preference.

14 COMMISSIONER GAZIANO: What was the 15 proposed day? I don't --

16 CHAIRMAN CASTRO: For August, it was 17 either have the meeting or not. It's already set 18 for August 16th.

19 VICE CHAIR THERNSTROM: I thought there
20 was a temporary -- we were putting the 16th
21 temporarily on hold.

22 CHAIRMAN CASTRO: Well, we put the 16th 23 down. What we put temporarily on hold was whether 24 or not we were going to proceed or not.

25 COMMISSIONER KLADNEY: Here's a

8	head.
9	COMMISSIONER KLADNEY: No, no.
10	CHAIRMAN CASTRO: I'm just turning to
11	look at you.
12	COMMISSIONER KLADNEY: Never mind.
13	CHAIRMAN CASTRO: Certainly you were
14	just joking?
15	COMMISSIONER KLADNEY: No.
16	CHAIRMAN CASTRO: Because I was looking

1 MS. SALLO: And it is our goal --2 COMMISSIONER HERIOT: What did you say? 3 SALLO: Your statements, which I MS. know a lot of folks are already preparing --4 5 COMMISSIONER HERIOT: Statements? We don't have 30 days to do our statement? 6 7 MS. SALLO: Well, we are in a bind right 8 now, because the first draft that was circulated to 9 the Commissioners has received significant revisions. And at this point in time, we are trying 10 11 our very best to send out an additional revised 12 report by next Monday. CHAIRMAN CASTRO: Which is the 17th? 13 14 MS. SALLO: Yes. 15 CHAIRMAN CASTRO: Okay. MS. SALLO: Which then puts us in a 16 position where I actually need comments by Friday 17 the 28th of June, in order to incorporate those 18 comments the week of July 1st, and then get the 19 20 report back to you once again with a goal that has

21 been, from the beginning, to vote on the final 22 report at the July 12th meeting.

COMMISSIONER HERIOT: And I was figuring
we would then have 30 days from that date to do our
statements.

SALLO: And if we do that, it's 2 going to put us past our statutory enforcement 3 deadline. COMMISSIONER GAZIANO: Well, let's work 4 5 out a schedule. We need -- I mean, let's do it now. 6 COMMISSIONER HERIOT: Hold on here. 7 COMMISSIONER GAZIANO: For all this. 8 MS. SALLO: Because we need to have the 9 plan to Pam, the actual report, by August 26th so we 10 can start working with GPO. And then we have to 11 publish it, and it has to be disseminated by 12 September 30th. 13 COMMISSIONER GAZIANO: Well, in the past, we've disseminated an electronic version, and 14 15 \_\_\_ MS. SALLO: And we will be. 16 17 COMMISSIONER GAZIANO: -- then worked out the formal dead wood version later. So let's 18 just --19 20 MS. SALLO: But you still need the GPO 21 to take a look at it and decide how it's going to be 22 laid out. 23 COMMISSIONER GAZIANO: I understand, but 24 be laid without most of it can out the 25 Commissioners' statements, and most of the work can

be done, and then you can add the Commissioners' statements. So if we do approve this July 12th, let's just say that the first Commissioners' statements are due August 12th, rebuttal would be, say, September 11th, or something like that.

6 MS. SALLO: Can we compress the rebuttal 7 time, please?

8 COMMISSIONER GAZIANO: I'd rather not. 9 And hopefully there will be no surrebuttal, and 10 therefore we'd be done September 11th. That would 11 leave almost 20 days to put it in -- but if 12 everything else is done on it, all charts, all 13 graphs, all everything, and you're just -- you know, 14 we Commissioners, we tend to just have a few words.

15 (Laughter.)

16 CHAIRMAN CASTRO: Few meaning googol.

17 COMMISSIONER HERIOT: But not very many18 charts.

19 COMMISSIONER GAZIANO: But not very many 20 charts or whatever. I would certainly hope that 15 21 days or so would be fine to append. And obviously, 22 you could be working on the original statements from 23 August 12th, and the only thing you'd need to add is 24 the rebuttal statements, if any, on September 11th.

25 MS. SALLO: My report needs to be to

1

copy editing the week of July 15th through the 26th.

I mean, that's the time period that I need to have it to the copy editor in order to be on track for our printing, in order to be on track for our publishing and for dissemination.

6 And when I talked to the folks up at the Hill, they really don't want paper copies. 7 They Which means that my staff has to do 8 want online. the actual email to each individual Senator and 9 Representative. And the deadline is September 30th, 10 11 so I need the time to get this done effectively, 12 efficiently, and appropriately.

COMMISSIONER GAZIANO: And I understand 13 that, and I think this schedule is -- Commissioners 14 15 are pretty much responsible for copy editing their There may be some details, page numbers 16 own work. and things that need to be inserted, but I would 17 think a few days would be -- I used to work at a 18 19 think tank that had publishing schedules and 20 published long documents, and copy editing could be 21 done in a few hours if necessary, but usually in a 22 few days, for --

MS. SALLO: Ah, but you had staff in-house that could do that.

25 COMMISSIONER GAZIANO: I understand, but

1 if everything else is done when Commissioners' 2 statements come in on August 12th, that's a month and a half. And the additional rebuttal statements, 3 the copy editing that would be associated with 4 5 additional rebuttal statements ought to be able to be done in a few days or a week. 6

7 COMMISSIONER KLADNEY: I'd like to just 8 say that I've noticed Commissioner Gaziano's 9 relaxation at this meeting as compared to the past, 10 when he was working elsewhere.

11 COMMISSIONER GAZIANO: I won't respond 12 to that. But anyway, Gail?

13 COMMISSIONER HERIOT: I'm worried, in 14 that my summer schedule is -- everything has to fall 15 into place exactly right. I've got other deadlines 16 for other projects. And I think I can compress the 17 time for my initial statement to less than 30 days. 18 I think that that's actually the end I feel most 19 comfortable.

But I've got -- I've been waiting on Supreme Court opinions that I've committed to write essays on, and they want it in mid-July, and there's no opinion for me to write about, so I'm in an awkward position. I was thinking, when I agreed to do that, that I was going to get an opinion in April and I would have it done before this meeting, but I

2 don't.

1

What's the latest that you think you candeal with on the initial statements?

5 MS. SALLO: If you -- if we wait until 6 the August meeting, that just puts us behind 7 completely, because then you have another clock 8 totaling for 30 days for rebuttal, which then pushes us into mid-September, and I just can't push the 9 final report into mid-September. We have a duty to 10 issue this by September 30th, and that to me is 11 12 front and center.

13 (Off-mic comments.)

14 MS. SALLO: I know, but I'm just 15 stressing how important it is that, the faster we get the initial statements submitted in July, the 16 17 faster we can get the rebuttals in and really make 18 this report come together to give us enough time to disseminate, to get it printed or --19

20 CHAIRMAN CASTRO: So how much earlier 21 than July 26th could we do those initial statements, 22 then?

23 COMMISSIONER HERIOT: Earlier than July24 26th?

25 CHAIRMAN CASTRO: Isn't that what you

1 said? 2 COMMISSIONER GAZIANO: No, we're talking 3 about August 12th. 4 CASTRO: CHAIRMAN Okay. Because I 5 thought you said Commissioners' statements, pressing that time. 6 7 COMMISSIONER HERIOT: Yes, but she did. 8 I mean, the 26th is a huge --9 CHAIRMAN CASTRO: Oh, so you want it less compressed than that, is what you're saying. 10 11 COMMISSIONER HERIOT: Less compressed, 12 yes. CHAIRMAN CASTRO: Okay. Never mind. 13 14 COMMISSIONER HERIOT: But more 15 compressed than what we were supposed to get. 16 COMMISSIONER GAZIANO: I still don't quite understand why August 12th is not -- a month 17 and a half is not early enough. 18 19 CHAIRMAN CASTRO: Well, that's my 20 birthday. Just kidding. 21 COMMISSIONER GAZIANO: Why August 12th 22 isn't early enough for initial statements, since 23 that's most of what we write. Why any compression 24 is necessary for a month and a half for copy 25 editing, especially since the main report's going to

1 be approved June 28th -- I'm sorry, July 12th. 2 That's two and a half months for copy editing. То 3 just copy edit our statements, it seems like a month and a half is fine for original statements. Why --4 5 I mean, we ought to be able to -- and I'm certainly willing to say, particularly on rebuttal statements, 6 7 that if I have typos in mine I'll bear the 8 embarrassment.

9 MS. SALLO: I don't want to bear the 10 embarrassment for the Commission.

11 COMMISSIONER GAZIANO: But how long does
12 it take? I mean, what's your --

MS. SALLO: Todd, I have to be honest. I haven't been here long enough to be overseeing this to give you a complete answer. I would be more than happy to go back and answer all the questions and send something out to all the Commissioners by early this afternoon.

COMMISSIONER GAZIANO: We've done -MS. SALLO: I can't explain the process
for copy editing.

22 COMMISSIONER GAZIANO: We've had similar 23 --

24 COMMISSIONER HERIOT: In the past, we've 25 gone much further towards the end of September.

1 COMMISSIONER GAZIANO: That's what I 2 We've sort of been over this, I think, the mean. 3 last five years, and that's why I was assuming that the schedule we were on was going to be consistent 4 5 with that. And I know that there is an awful lot of work, and I didn't mean to minimize that. But I 6 know, and it's sort of been my understanding, the 7 way we've done this in the past, that most of that 8 9 work proceeds while Commissioners are writing 10 statements.

MS. SALLO: So if I were to say "Go ahead and give your statements by the August meeting," can you --

14 COMMISSIONER GAZIANO: I think we can 15 set the schedule for the statements to be 16 independent of meeting dates. So if, for example, 17 we want to say around August 10 -- I don't know what 18 day of the week that is.

19MS. SALLO:I will let you know in a20second.

21 COMMISSIONER HERIOT: It's a Saturday.
22 MS. SALLO: It's a Saturday. So if you
23 were to say to submit it to me by August 9th -24 COMMISSIONER HERIOT: But that's only
25 two days. I can chop more off the time than that,

SALLO: Okay. 8 COMMISSIONER HERIOT: Todd, can you get 9 it in two weeks before that, one week before? 10 COMMISSIONER GAZIANO: I'd rather -- I'm 11 not sure why it's necessary to compress it any, but 12 a week is as much as I'd want to do. 13 COMMISSIONER HERIOT: How about that? The fourth? 14 15 COMMISSIONER GAZIANO: Could we go through a Sunday? 16 17 MS. SALLO: That's a Sunday. 18 COMMISSIONER HERIOT: Get it in by midnight Pacific time, which is -- it's when I do my 19 20 best work. 21 COMMISSIONER GAZIANO: I hate being 22 allowed to work until 3:00. 23 COMMISSIONER HERIOT: I love it. COMMISSIONER GAZIANO: Pardon? 24 25 COMMISSIONER KLADNEY: I didn't say a

1 word. 2 COMMISSIONER GAZIANO: Okay. And then I 3 suppose rebuttals would be September 3rd? 4 MS. SALLO: Yes. 5 COMMISSIONER GAZIANO: Can we approve that as the tentative for right now? 6 7 So Tuesday, September 3rd, MS. SALLO: 8 you want the rebuttal? Or do you want it Sunday, September 1st? 9 10 COMMISSIONER GAZIANO: Tuesday, 11 September 3rd. 12 CHAIRMAN CASTRO: Isn't this really interesting, interns? 13 14 (Laughter.) 15 MS. SALLO: Then we're set in stone? 16 CHAIRMAN CASTRO: Maybe clay. 17 COMMISSIONER GAZIANO: Yes, maybe clay. 18 CHAIRMAN CASTRO: Is there a motion, 19 then? Do we need a motion on this? 20 MS. CHAIRMAN CASTRO: As you recall, at our 2 briefing last month we heard from Major Kamal Kalsi. He highlighted the issue of a presumptive ban in 3 the Armed Forces for service by Sikh Americans who 4 5 items that integral would wear are to their expression of religious faith: their facial hair, 6 7 unshorn hair, and their turbans.

8 And after the briefing, I think many of us were moved by that presentation -- there was a 9 brief conversation 10 bipartisan among some 11 Commissioners about the possibility of exploring, in 12 advance of a report, a letter by the Commission on 13 this topic. And so I took it upon myself to draft And since I don't have a special 14 something. 15 assistant right now, Alec has been kind enough to be partially detailed to me by Commissioner Achtenberg 16 to help with meeting prep, I though "Oh, I'll give 17 it a shot." And I didn't get a draft out to folks 18 until the wee hours of this morning, so I don't 19 20 intend to review for approval a letter today.

21 I just wanted to get something out so 22 that we could begin a discussion and consideration of this at some point in the future as to some 23 24 letter that we would draft, and I just addressed it 25 here to individuals, but it could be -- talking to

some Commissioners, perhaps it's an initial request to the Army for a response on this. But just the concept of this, I wanted to share with folks so that we can begin a conversation, and hopefully at maybe the next meeting be in a position to have a letter that we would all be comfortable supporting, to at least address this emergent issue.

8 Ι think it's not necessarily an 9 emergency, but it's something that I think many of us were not aware of, and it's a significant issue 10 11 in the Sikh community. So I'm happy to open it up 12 and get some input and some thoughts, but again, I don't intend to vote on this today. 13

14 Yes, Commissioner Heriot?

15 COMMISSIONER HERIOT: I think that we're on the right track that this is an issue that the 16 Commission ought to be able to deal with, but I do 17 18 think we've skipped a step here, and that is that we 19 need to go to the Army and ask them exactly what 20 their policy is and why. And this may be simply an 21 issue where we can perform a function as а 22 negotiator here, to bring the issue to the 23 military's attention and try to come with up 24 something that would accommodate the needs of both 25 sides.

COMMISSIONER KLADNEY: Mr. Chairman?

CHAIRMAN CASTRO: Yes?

1

3 COMMISSIONER KLADNEY: I think that we 4 actually need to ask all the service branches for a 5 response.

6 CHAIRMAN CASTRO: Yes. I agree. And my 7 initial thought was the Secretary of Defense, but it 8 is actually an Army regulation that came up. But 9 you're right, there is a DoD policy as well, so I 10 think asking all the branches would be important, 11 not just the Army.

VICE CHAIR THERNSTROM: Mr. Chairman?
CHAIRMAN CASTRO: Yes, Madam Vice Chair,
and then Commissioner Gaziano. Madam Vice Chair?

15 VICE CHAIR THERNSTROM: When we ask about this issue to whatever authority is going to 16 end up being appropriate, I would like it to be put 17 in a larger context of military rules. 18 Because people volunteer for the Army. Nobody is drafted. 19 So you're volunteering for a really -- service in a 20 21 very special organization in American life. And you 22 know, in general I would like to know what are the 23 liberties you give up? What are you signing onto? I mean, I need a broader context here in order to 24 25 think about this specific one.

1 CHAIRMAN CASTRO: Well, that sounds like 2 a concept paper to me. But I don't know how we would go about doing that and stay focused on this, 3 but perhaps there is some more context that may not 4 5 be that extensive that may be of some assistance in framing this. We can explore that, but I don't 6 7 necessarily want this to turn into a law review 8 article.

9 VICE CHAIR THERNSTROM: Right.

CHAIRMAN CASTRO: Any other comments?
 Oh Commissioner Gaziano.

12 COMMISSIONER GAZIANO: Yes, I wanted to thank the Chair for putting it on the agenda and 13 drafting the letter. I, like I think probably 14 15 everyone else, was moved by Major Kalsi's personal statement, and very well-put, and I think very 16 17 respectfully put. And one of the reasons I am even 18 more inclined to pursue it is because he was so -in some sense, thankful and respectful for those who 19 20 had eventually accommodated him. And you always 21 want to help someone who is not hyperbolic in 22 putting their claim.

At the same time, I too want to hear from the different services, and I wanted to draw to the Commissioners' attention that, in our role in

1 sort of seeking -- or possibly seeking a change in 2 policy, possibly seeking a greater flexibility in accommodation, we're sort of playing a policy rule. 3 There is a Supreme Court case that most of you I'm 4 5 sure know, of Goldman v. Weinberger from 1986, and in it the Supreme Court (7-2) held that an ordained 6 rabbi who was also a medic in the Air Force did not 7 8 have a 1st Amendment constitutional right for an 9 exemption from the Air Force's then policy that he wear a yarmulke. 10

11 And what was interesting about the facts 12 of that case is that he was sort of able to get away with wearing his yarmulke, because inside the clinic 13 -- he tried to stay inside the clinic. When he went 14 15 outside, he wore his service cap on top. So obviously there was no issue with regard to whether 16 17 he could wear a helmet or gas mask, as was 18 supposedly one of the concerns in accommodated Sikh 19 Americans in the military.

20 There's just some language in the 21 Supreme Court opinion that's at least slightly 22 instructive as far as the military's interest in uniform dress and appearance and subordinating the 23 24 individual having and any outward siqn of 25 differences subordinated solely to rank. And those

But I think some of the things that the 6 Supreme Court wrote about may inform our policy 7 8 views. 9 CHAIRMAN CASTRO: I'll take a look at 10 that. 11 COMMISSIONER GAZIANO: And it is a good 12 reason to hear from the services. CHAIRMAN CASTRO: Absolutely, and thanks 13 for bringing that case to our attention. We'll take 14 15 a closer look at it. Any other feedback, input? 16 17 (No response.) 18 CHAIRMAN CASTRO: If not, then we'll take that and run with it, and follow up and put it 19 the agenda next, and hopefully we'll have 20 on 21 something a little more solid. Thank you. 22 So next on the agenda is -- actually, 23 both items are our Staff our next Director 24 reporting, both on the status update on the issue of 25 agency reorganization, and then I'll let her go

right into the Staff Director's Report after that.

## Status Update on Agency Reorganization

Thank you, Mr. Chairman. 4 MS. SALLO: As 5 the Commission is aware, during the continuing resolution earlier this year, we were instructed to 6 look at our organization and to come up with a 7 report that needed to be submitted to the Committees 8 on Appropriations that addressed any ideas that we 9 10 might have to reorganize both the Commission here at 11 headquarters, as well as the regional offices and 12 the regional programs, and to report back to them as to how the work that we're currently doing is 13 beneficial to our mission. 14

15 Because my appointment became official two weeks ago and we had yet to address the very 16 important directive to perform reorganization or to 17 provide a report on possible reorganization, I have 18 submitted letters requesting a 90-day extension to 19 20 the Committees on Appropriations in both the House 21 and Senate. Thus far, Ι have received one 22 confirmation that the extension will be granted, and that's from the Majority Office in the House. 23 I have sent emails as a follow-up to everyone else, 24 25 and hopefully they will get back to me by close of

business today. But going into this, when I did submit the letters, they had said that they were amenable to hearing from us and possibly granting a reasonable extension. So once I receive final confirmation, I will let the Commissioners know.

6 So that you are aware, I have started 7 looking our internal structure and our different 8 positions, and I will be meeting with folks and 9 requesting input as well from the Commission, as I 10 move forward in putting together a reorg report for 11 Appropriations.

12 CHAIRMAN CASTRO: Any questions?

13 (No response.)

MS. SALLO: And then moving on to theStaff Director Report.

16 III. Management and Operations

17 Staff Director's Report

MS. SALLO: I put together my first Staff Director Report and I did disseminate it. It was a very short reporting period. The period ran from May 13th through May 24th. I don't know if anyone has any particular questions as to what was indicated in the report.

I did want to bring to the forefront the fact that we have been undergoing an audit by the Office of Ethics, and we did meet, had our entrance meeting with our auditors that occurs every year around the summer, so we have had our entrance meeting with them as well. We continue to move forward in getting staff reports approved to be uploaded onto our website.

7 We have also submitted a request to 8 allow us to change our regs, so we have a 12 month 9 period wherein if we want to submit any changes to 10 our regulations we will be allowed to do so, and 11 that should become live soon, because the spring 12 regulation agenda has yet to go live on the web.

As we move forward, I know that there is 13 a concern about current positions that remain open. 14 15 Obviously, the goal is to bring in any necessary employees that we need in order to meet our mission. 16 I know that there have been questions about filling 17 two particular positions, OGC and OCRE Director. 18 At this point in time, I think it would be in our best 19 20 interests to only move forward on filling one 21 position and not both, simply because although we 22 currently have money in our budget, there is no --23 we have no idea as of yet what our budget is going to look like in 2014. 24

25

As we move forward in preparing our 2015

1 budget, we have been instructed that we have to come 2 up with a budget that's five percent, as well as 10 3 percent, below our control number, and our control number is 9.4 million dollars, and that's before the 4 5 money that goes to the IG. So we're currently in the process of looking at how to put that together. 6 7 forward, I will advise So as Ι move the 8 Commissioners -- I'll keep you apprised of any 9 movements that we have in reference to putting together a reorg plan. And if you have 10 any 11 questions, I'm more than able to answer. 12 CHAIRMAN CASTRO: Any questions for the Staff Director? 13

14 VICE CHAIR THERNSTROM: I have a 15 question.

16 CHAIRMAN CASTRO: Go ahead, Madam Vice17 Chair, then Commissioner Yaki.

18 VICE CHAIR THERNSTROM: No, whoever also19 had one.

20 COMMISSIONER YAKI: No, I defer to the 21 Vice Chair.

VICE CHAIR THERNSTROM: Welcome, by the
way, to your first meeting as Staff Director. I'm
delighted to have you.

25 MS. SALLO: Thank you.

1 VICE CHAIR THERNSTROM: Ι think in general, and maybe other Commissioners don't share 2 this view, but I think in general we need more 3 information about the budget. How much money we 4 5 have, what it's being spent on, what we can afford. I mean, at the last meeting, the briefing that was 6 held in the Marriott, I assumed that was quite an 7 expensive decision. And I would have liked to have 8 9 known exactly what that cost us, what the tradeoffs 10 were in terms of was it money that would have come out of X or Y commitments, or potential commitments. 11 12 I mean, this has been true ever since I got on the Commission. There has not been enough information 13 given to Commissioners about the budget and where we 14 15 stand, and what we're spending money on, and how 16 much.

17 I totally appreciate you MS. SALLO: bringing that to my attention. I will try, as I 18 move forward and I get more comfortable in this 19 20 position, I'll be more than happy to answer any 21 questions. What I can tell you right now is we 22 currently have a balance of about 3.4 million. 23 However, that doesn't mean that it's there to be 24 used, because what goes against that money is 25 obviously the continued salaries until the end of

this fiscal year, any outstanding travel that the Commissioners may have, the Commissioners' timesheets, any outstanding obligations that we have to pay off anything that we've purchased thus far.

5 So at least I can give you that ballpark 6 figure today, because that's what I'm ready to speak 7 about, and then next month we can take it from there 8 and I can be a bit more comprehensive, if that's 9 okay with you, Madam Vice Chair.

10 VICE CHAIR THERNSTROM: That's fine.
11 And would you like to make a comment on how much
12 moving the briefing to the Marriott cost?

MS. SALLO: I'm sorry, Ma'am. I don't have those numbers in front of me. But if everyone is interested in having that information, then I can relay that to you.

17 VICE CHAIR THERNSTROM: Well, I at least 18 would be. But I don't want you working solely for 19 me.

20 CHAIRMAN CASTRO: Any other -21 Commissioner Yaki, you had a questions.

22 COMMISSIONER YAKI: This is directed at 23 you, Mr. Charles, as well as the Staff Director. 24 But at what point should we go to ask the Senate for 25 relief from the IG expenditure? Ask if it can be every other year, every four years, or something like that, because it's disproportionate to our budget, for agencies our side. I think we offered that at the time, and if this is something that we're ready to do at this point, ask for signatures, I'd be the first one to volunteer to help do that.

7 CHAIRMAN CASTRO: I know we have had 8 conversations around that issue already when I and 9 then my special assistant, now the Staff Director, 10 as well as our head of management and operations, Tina Martin, and John, I don't remember if you were 11 12 with us. We were asked to appear before the House -- well, not to appear, but to meet with the House 13 Appropriations Staff, and I know that those issues 14 15 are issues that they're thinking about as well.

We have not had a formal conversation 16 with the Senate on that, but I do know that those 17 are conversations that are already beginning, as to 18 19 how the IG will apply, or what funds go to it, 20 especially since, as our IG has done their work, 21 they're not really finding any issues, and so there 22 may be a way to adjust those. What that adjustment 23 may or may not be, we don't know. So I think you're right, we will follow 3 4 up on those. 5 COMMISSIONER YAKI: Thank you, Mr. Chair. 6 7 CHAIRMAN CASTRO: You're welcome. Thank you. Any other questions. 8 9 (No response.) CHAIRMAN CASTRO: 10 If not, is there 11 anything else you have on your Staff Director 12 Report? MS. SALLO: No, sir. 13 CHAIRMAN CASTRO: Okay. 14 Thank you. The 15 next item under Management and Operations is a report from the Chief of Regional Programs. 16 17 III. Management and Operations Chief of Regional Programs Report 18 19 CHAIRMAN CASTRO: David Mussatt, if you could approach the microphone, please? Oh, Acting 20 21 Chief. 22 MR. MUSSATT: Good morning. 23 CHAIRMAN CASTRO: Good morning. 24 MR. MUSSATT: I submitted the RPC 25 monthly report, so if you have any questions feel

1 free to ask me. But I just wanted to -- since it's 2 been a few months since I appeared before you, I 3 wanted to update you on a few things that have gone 4 on.

5 First, just some positive news that I wanted to share, and it may be in the PAU report, 6 but it's always good to repeat positive stuff. 7 It's 8 some press that the advisory committees have been 9 receiving. In the past few months, the New Hampshire Advisory Committee, its report on 10 the 11 inequality of women's prisons was cited, and the 12 Chair was quoted, in the Concord Monitor dealing with Governor Hassan's inclusion of money for a new 13 women's prison in the State budget. 14

15 Last week, the Ohio Advisory Committee held a fact finding meeting in Toledo, Ohio, which 16 international and national hub of 17 is an human 18 trafficking, and they held it on that topic. And all three major local TV affiliates covered it. 19 We 20 had quite lengthy articles in the Toledo Blade, a 21 major local paper, and also an article posted on the 22 Faith and Values website.

Also, this Sunday, a story is scheduled to be printed in the Savannah Daily News that will feature findings from the Georgia SAC reports on 1 school desegregation. So all good things going on

2 in the regions that I wanted to share with you.

3 A couple other new developments from our GSA committee management secretariat. 4 They have 5 made live and available for use their new userfriendly database of federal advisory committees. 6 7 Ιt is also easier website address, an just 8 facadatabase.gov, and that's FACA, F-A-C-A, 9 database, one word, dot gov. And in that, you can access the minutes to SAC meetings, you get an end-10 11 of-year budget, to the Vice Chair's question about 12 money.

13 So there's -- it's much more user-14 friendly than the old system. If you remember the 15 old system, it was kind of clunky, and this is a lot 16 more efficient. There may be some glitches, and 17 things may not be updated. It just came live, so 18 I'm not sure how everything transferred over to the 19 new system, but it's worth looking at.

20 Also, if Commissioners or their 21 assistants are interested, GSA now has made the FACA 22 management course 101 available free and online for 23 staff to be trained, or retrained, whatever the case 24 may be, in FACA matters. It's a pretty lengthy --25 my interns just did it last week. It's five or six 1

25

hours, and you have to take a test at the end of it.

But it's a pretty thorough introduction to FACA for people who are interested in it. It also is for our DFOs in the field, required to be able to take the 201 course, the more advanced class, which is an inperson class in DC and costs money. So those are two interesting developments from our committee management secretariat.

And then the only last quick thing is, I 9 10 wanted to highlight that submit just Ι the 11 reappointment spreadsheets every month, and a few 12 months ago I kind of started highlighting the last column, which is when SACs are to be reappointed 13 within 90 days. And for the Commissioners, I just 14 15 wanted to bring that to your attention, they're highlighted in blue, so when you go through that 16 spreadsheet and you see a blue box at the end of it, 17 that's a state that's going to be coming up for 18 reappointments, so if you know people in that state 19 20 that you'd like to nominate please send those names 21 to our new Staff Director.

22 MS. SALLO: May I?

23 CHAIRMAN CASTRO: Yes, Madam Staff
24 Director?

MS. SALLO: And I will also be sending a

VICE CHAIR THERNSTROM: 19 No. 20 CHAIRMAN CASTRO: No? So I'll make the 21 motion. Do I have a second? 22 COMMISSIONER KLADNEY: Second. 23 CHAIRMAN CASTRO: Okay. All in favor, 24 say aye. 25 (Chorus of ayes.)

3	VICE CHAIR THERNSTROM: No, I always
4	oppose. I always oppose on principle.
5	CHAIRMAN CASTRO: Any abstentions?
