# U.S. Commission on Civil Rights Announces Panelists for Briefing Related to *Quiet Crisis:* Federal Funding and Unmet Needs In Indian Country, 2016 Update

WASHINGTON – The U.S. Commission on Civil Rights announced today the names of the panelists who will speak before the Commission on February 19<sup>th</sup>, 2016. The briefing will examine education, health, public safety, housing, rural development and economic opportunity in the Native American Community for the Commission report titled "Quiet Crisis: Federal Funding and Unmet Needs in Indian Country, 2016 Update."

Commissioners and Panelists will have the opportunity to discuss the steps taken to implement the recommendations presented in the 2003 report as well as future actions that must be taken to address unmet needs in Indian country.
