2	(4:49 p.m.)
3	I. OPEN MEETING
4	CHAIRMAN CASTRO: We are coming back into
5	session, and we're continuing now for the business
6	meeting. It is 4:49 p.m. eastern time. On the phone
7	we have Vice Chair Timmons. Are you still there, Madam
8	Vice Chair?
9	VICE CHAIR TIMMONS-GOODSON: I am, Mr.
10	Chair.
11	CHAIRMAN CASTRO: And then we have in
12	person Commissioners Narasaki, myself, Kladney, and
13	Achtenberg. That gives us a quorum. And I am assuming
14	Commissioners Yaki and Kirsanow are not on the phone?
15	COMMISSIONER KIRSANOW: Kirsanow is here.
16	CHAIRMAN CASTRO: Okay, but you're
17	recusing? No, you're not recused on this, right, or
18	are you?
19	COMMISSIONER KIRSANOW: If we're voting
20	on the trip to - I will recuse myself for everything
21	dealing with environmental justice.
22	CHAIRMAN CASTRO: Okay, then that's - all
23	right. So you'll be able to vote on the Quiet Crisis
24	one then.

1	COMMISSIONER KIRSANOW: Right.
2	CHAIRMAN CASTRO: Okay, got it, so we do
3	have a quorum then.
4	II. DISCUSSION ON ALABAMA TOWN HALL
5	CHAIRMAN CASTRO: For those of you who
6	recall, we were going to try to conduct a town hall in
7	Uniontown, Alabama in late February, and because of
8	that, we decided we were going to move our Quiet Crisis
9	mini-briefing to a later time. However, because of
10	various logistical matters, we were not able to do the
11	town hall at the end of February.
12	So what I'd like to discuss is the
13	possibility of doing a town hall in Uniontown, Alabama
14	at the end of March. And as a result, if we do decide
15	to do that, then to continue to have our Quiet Crisis
16	briefing when it was originally set on February 19.
17	I'll open it up for discussion or any motions folks
18	might have. Commissioner Narasaki?
19	COMMISSIONER NARASAKI: I do think that if
20	we are moving the town hall back, that in order to save
21	money, we need to move the Quiet Crisis back to the
22	February date, because otherwise, we'll have to incur
23	additional costs to extend the writer's contract that
24	we have because originally we were moving that back in

order to accommodate the town hall, but that was going
to cost apparently an enormous sum of money that we
don't have.
So I know it's ideal for people to have to
come back in two weeks and do another hearing, but -
and I'm sure it's not fun for staff either, but I feel
like from a budget standpoint, we just don't have a lot
of options.
CHAIRMAN CASTRO: Okay, Commissioner
Achtenberg?
COMMISSIONER ACHTENBERG: Mr. Chairman,
when you say the end of March -
CHAIRMAN CASTRO: I believe the date we
are working with is March 31.
COMMISSIONER ACHTENBERG: March 31.
CHAIRMAN CASTRO: Was I right?
COMMISSIONER ACHTENBERG: So it would be
travel on the 30th, the hearing on the 31st, and then
travel on the 1st?
CHAIRMAN CASTRO: Something like that.

that, okay, great. Thank you very much. Oh, thank
you. I'm sorry, okay.

CHAIRMAN CASTRO: Okay, any other

COMMISSIONER ACHTENBERG: Something like

1	questions or discussion? Commissioner Narasaki?
2	COMMISSIONER NARASAKI: I just want to add
3	I know that Commissioner Heriot -
4	CHAIRMAN CASTRO: Yes.
5	COMMISSIONER NARASAKI: - had made it
6	clear that she was very interested in having the - in
7	going forward with the hearing. At least that's the
8	last exchange I saw. I'm a little more up in the air,
9	but I just wanted to represent her since she wasn't able
10	to be here today.
11	CHAIRMAN CASTRO: Yes, she did share an
12	email with me, and my special assistant circulated it
13	to all of you, and I thought I had a copy here to read
14	into the record if we wanted to, but I can't seem to
15	locate it. Do you have it? Oh, here it is. Thank
16	you.
17	"Gail is strongly in favor of holding a
18	field briefing in Uniontown. If the Commission goes
19	to Uniontown, it is also very important to her that the
20	Commission tour the Arrowhead landfill while there.
21	As she has said before at Commission meetings, it is
22	extremely important to her that the Commission conduct
23	independent research and avoid merely repeating the
24	work of others."

1	"She is available on the two dates that
2	have been discussed as likely candidates, March 3 or
3	March 31," and March 31 is the one we're talking about,
4	"although she has to teach classes in Washington on the
5	respective Wednesdays before, and therefore cannot
6	travel until Thursday morning."
7	"It is therefore also important that the
8	Commission schedule a tour, or the tour of the Arrowhead
9	landfill facility for Friday morning rather than
10	Thursday morning so that she can attend it, "okay.
11	Commissioner Achtenberg?
12	COMMISSIONER ACHTENBERG: Mr. Chairman, I
13	agree that it's important to tour the facility, but I
14	think what's equally as important is to speak with as
15	many neighbors as we possibly can. Because it's my
16	understanding that at this point, although the transfer
17	of coal ash was pretty traumatic and quite a dramatic
18	event, right now at this point, you know, I'm told they
19	have capped it off. And so, you know, I think this is
20	ongoing.
21	CHAIRMAN CASTRO: Right.
22	COMMISSIONER ACHTENBERG: This is not
23	just one point in time.
24	CHAIRMAN CASTRO: A snapshot.

1	COMMISSIONER ACHTENBERG: Yes.
2	CHAIRMAN CASTRO: Absolutely.
3	COMMISSIONER ACHTENBERG: So I agree with
4	Commissioner Heriot, but there is something that's as
5	important, and in my view, more important, and that's
6	-
7	CHAIRMAN CASTRO: The town hall.
8	COMMISSIONER ACHTENBERG: - getting the
9	town -
10	CHAIRMAN CASTRO: Right.
11	COMMISSIONER ACHTENBERG: - hear from the
12	town about what this has meant and the collective burden
13	as so many of the witnesses identified today, assessing
14	the collective burden, I think, is extremely important
15	as well.
16	CHAIRMAN CASTRO: Thank you.
17	Commissioner Kladney?
18	COMMISSIONER KLADNEY: I agree with
19	Commissioner Achtenberg. I think even though they're
20	not accepting any more coal ash at the facility, and
21	it's been capped off and put in a better condition than
22	it was, I would think OCRE and our staff can collect
23	photographic evidence of how it was. And I think it's
24	a good idea for us to do interviews during the day as

1	well of the neighbors who have complained, as well as
2	those who signed, I guess, the three affidavits for the
3	company.
4	CHAIRMAN CASTRO: Absolutely.
5	COMMISSIONER KLADNEY: I'd like to
6	interview them as well, and do that outside the presence
7	of the -
8	CHAIRMAN CASTRO: The company?
9	COMMISSIONER KLADNEY: - the town hall.
10	CHAIRMAN CASTRO: Oh, the town hall.
11	COMMISSIONER KLADNEY: I mean, if the
12	company wants to be there, I guess they're entitled to.
13	But I think that's all important, especially in sight
14	of the fact that the conditions have changed down there
15	with the capping of the coal ash.
16	CHAIRMAN CASTRO: Madam Vice Chair, do you
17	have anything you want to say?
18	VICE CHAIR TIMMONS-GOODSON: I just find
19	myself thinking that often it's what's below the
20	surface. I hate to keep going back to Flint, but one
21	would not know the level of damage done by this lead
22	just upon looking at it.
23	So I find myself thinking what might there

be more that we should be looking at that would give

1	us a sense of the conditions and - that are below the
2	surface? I just throw that out. It may not
3	necessarily make any sense, but that's what I find
4	myself thinking.
5	And so I don't know if there's some health,
6	I don't know, not records, individual health records.
7	We certainly could not get those, but I'm just wondering
8	if there might be some health data.
9	CHAIRMAN CASTRO: Yes, what you're saying
10	makes sense, Madam Vice Chair.
11	VICE CHAIR TIMMONS-GOODSON: I'm sorry,
12	can you hear me?
13	CHAIRMAN CASTRO: Yes, I said what you
14	said makes sense.
15	VICE CHAIR TIMMONS-GOODSON: Oh, okay,
16	but that's just what I was thinking, Mr. Chair.
17	CHAIRMAN CASTRO: Okay, thank you.
18	Commissioner Achtenberg, do you have a motion?
19	COMMISSIONER ACHTENBERG: Yes, Mr.
20	Chairman, I mean, the Vice Chair makes an excellent
21	point. To the extent that there is - has been any
22	private well testing, for example, any testing of the
23	waterways, I mean, because the big -
24	VICE CHAIR TIMMONS-GOODSON: Yes.

1 COMMISSIONER ACHTENBERG: One of the big challenges is the fact that this stuff leaches into the 2 - onto the water table and fouls the water that people 3 4 - you know, so we need to do some data collection in that regard as much as exists, and if it doesn't exist, 5 maybe that's something that we need to look into and 6 7 think about making recommendations with regard to it. 8 CHAIRMAN CASTRO: Yes, and you know, I 9 think particularly in the last five years that we've 10 been working together, and the last couple that we've 11 been working together, that we've really tried to make 12 an effort to resuscitate this agency as the nation's 13 conscience on civil rights. And I keep thinking about the fact that 14 15 last year's statutory enforcement report was important, but it was most powerful because we actually 16 17 went to those detention centers to see what we were 18 hearing about firsthand, and I think that helped not 19 only make the report more powerful, but more credible. And therefore in that same view, I think 20 21 that while we've heard a lot today, and what we heard 22 from the EPA, and the data we've read that, you know, 23 we could write a report based on what we have, but I 24 don't think it will be as powerful as if - unless we

1	go and look at a representative site and say, "We are
2	the Civil Rights Commission, and we have heard the
3	community, and we want to see this for ourselves." I
4	think it's important for us to do that. I know maybe
5	not everyone agrees here, but I certainly think it's
6	important for us to do that. So do we have a motion?
7	COMMISSIONER ACHTENBERG: So moved.
8	CHAIRMAN CASTRO: So the motion is to
9	conduct -
10	VICE CHAIR TIMMONS-GOODSON: Yes, Mr.
11	Chair? I move that we go there to the site in Alabama
12	as we have discussed so that the Commission can see for
13	itself what's going on there.
14	CHAIRMAN CASTRO: Okay, is there a second?
15	COMMISSIONER ACHTENBERG: Second.
16	CHAIRMAN CASTRO: Any additional
17	discussion? If not, I will do a roll call vote.
18	Commissioner Kirsanow, you are recusing itself, and
19	Commissioner Heriot is absent. Commissioner
20	Narasaki, how do you vote?
21	COMMISSIONER NARASAKI: I abstain.
22	CHAIRMAN CASTRO: Okay, Commissioner
23	Kladney, how do you vote?
24	COMMISSIONER KLADNEY: Yes.

1	CHAIRMAN CASTRO: Okay, Commissioner
2	Achtenberg, how do you vote?
3	COMMISSIONER ACHTENBERG: I vote, as the
4	Commissioner from the State of California, I vote a
5	proud yes.
6	CHAIRMAN CASTRO: Commissioner - I should
7	say Madam Vice Chair, how do you vote?
8	VICE CHAIR TIMMONS-GOODSON: Yes.
9	CHAIRMAN CASTRO: Commissioner Yaki, are
10	you on the phone? Okay, so he'll be listed as absent.
11	And as the Commissioner from the State of Illinois, I
12	vote yes. So Commissioner Kladney, we're coming back
13	to you.
14	COMMISSIONER KLADNEY: I've really
15	thought about this a lot.
16	CHAIRMAN CASTRO: I can tell.
17	COMMISSIONER KLADNEY: Yes, I have. I'm
18	just struggling with it because I understand what we're
19	saying, and I understand what we're doing, but I'm going
20	to -
21	CHAIRMAN CASTRO: You'll just vote yes.
22	COMMISSIONER KLADNEY: I know you want me
23	to vote yes, Mr. Chairman.
24	CHAIRMAN CASTRO: I know.

1	COMMISSIONER KLADNEY: Well, I guess I'm
2	on the needle, huh?
3	CHAIRMAN CASTRO: You don't have to go,
4	but you can still vote yes.
5	COMMISSIONER KLADNEY: Okay, I'll vote
6	yes.
7	CHAIRMAN CASTRO: Thank you. So we have
8	four yeses and two abstentions of the motion. Wait a
9	minute. Oh, you're - what? You're changing your
10	mind?
11	COMMISSIONER NARASAKI: Yes, because I
12	feel bad for Commissioner Heriot not being here, so on
13	her behalf, I will change from an abstention to a yes,
14	even though I was trying to pull a Kirsanow.
15	CHAIRMAN CASTRO: Okay, so your vote has
16	been changed to a yes, so we have five yeses and one
17	abstention. The motion passes. Pete recused
18	himself, so, I don't know. I'm just treating it as a
19	recusal. It's a separate issue, right? Yes, yes, so,
20	two separate types of issues. So that motion passes,
21	okay.

18	Achtenberg, how do you vote?
19	COMMISSIONER ACHTENBERG: Yes.
20	CHAIRMAN CASTRO: Commissioner Yaki, are
21	you there? Still absent. Madam Vice Chair, how do you
22	vote?
23	VICE CHAIR TIMMONS-GOODSON: Yes.
24	CHAIRMAN CASTRO: And I vote yes, so it is
