CHAIRMAN CASTRO: It is now 2:00. I am going to call the meeting to order. This is a business meeting of the U.S. Commission on Civil Rights. As I indicated, it's 2:00 p.m. Eastern Time on March 14th. We are at the Commission's headquarters, 1331 Pennsylvania Avenue, N.W., in Washington, D.C.

I'm Marty Castro, the Chair. Commissioners who are present here in the meeting with me are Commissioner Heriot, Commissioner Achtenberg, and Commissioner Kladney. Commissioners Yaki and Kirsanow are joining us by phone. Is the court reporter present? He's nodding yes. Is the Staff Director present?

MS. SALLO: Present.

CHAIRMAN CASTRO: Okay, so we have a quorum. The meeting will now come to order.

The first item is the Approval of the Agenda.

CHAIRMAN CASTRO: So, I will move that we approve the agenda. Is there a second?

COMMISSIONER HERIOT: Second.

CHAIRMAN CASTRO: Are there any amendments to the agenda? Madam Staff Director?

23 President and Congress respectively make a national
24 holiday for Cesar Chavez, and also a day of
25 Commemoration Day of Service. And a second letter on

1 Fred Korematsu who I=m sure you=re all familiar with
2 was involved in the litigation in the Supreme Court over
3 Japanese-American Internment during World War II,
4 requesting the same holiday, as well as commemoration
5 for his service in the civil rights arena.

6 So, what I would like to do is take each
7 of those letters individually. So, what I will do, first
8 of all, is move that we B- and this will be for B-

9 (Pause.)

10 CHAIRMAN CASTRO: The mic went off? That we
11 approve B- I=ll make a motion that we approve as a
12 Commission the copy of the letter that was circulated
13 to each of you to the President and Congress on behalf
14 of the making of the national holiday for Cesar Chavez,
15 along with a National Day of Service. Is there a second
16 to that?

17 COMMISSIONER ACHTENBERG: Second.

18 CHAIRMAN CASTRO: Do we have any discussion
19 or any proposed changes that folks want to make to that?
20 All right, hearing none B-

21 COMMISSIONER KIRSANOW: Mr. Chairman.

22 CHAIRMAN CASTRO: Okay. Go ahead,
23 Commissioner Kirsanow. Please, go ahead.

1 statement as to why.

2 CHAIRMAN CASTRO: Sure, go ahead.

3 COMMISSIONER KIRSANOW: It has nothing to
4 do with the merits of Mr. Chavez, or in the subsequent
5 vote on Mr. Korematsu. It has to do with the fact that
6 I oppose any national holidays at all. We've got
7 national holidays up the wazoo. Each national holidays
8 take money out of people=s pockets, it hurts the
9 economy, and I don=t think we need any more national
10 holidays. We've consolidated some national holidays.
11 And although I do believe that honoring these
12 individuals is something that should be done, it
13 shouldn=t be done by virtue of a national holiday.

14 There are number of individuals who are
15 equally meritorious of a national holiday, anyone from
16 Frederick Douglass to Rosa Parks, to you name it, Homer
17 Plessy, James Meredith, Roger Williams, Harriet
18 Tubman, so I don=t know at what point we draw the line.

19 CHAIRMAN CASTRO: Thank you, Commissioner
20 Kirsanow. Commissioner Heriot wanted to make a
21 statement.

22 COMMISSIONER HERIOT: I believe that these
23 two individuals are, indeed, worthy of an honor. I think
24 there are lots of other people who are also worthy of
25 an honor. My personal favorite if there=s ever going

1 to be another national holiday would be Norman Borlaug,
2 but I am willing to vote against that one, too. So, I
3 would vote against giving them a holiday.

4 CHAIRMAN CASTRO: Okay, who=s squiggling
5 around in their chair? They maybe want to mute it on
6 the phone. Thank you. Any other comments, questions
7 from any other Commissioners?

8 COMMISSIONER YAKI: I B-

9 CHAIRMAN CASTRO: Commissioner Yaki.

10 COMMISSIONER YAKI: We=re dealing just now
11 with the Cesar Chavez letter.

12 CHAIRMAN CASTRO: Yes, exactly. I thought
13 I would take them each individually in the event people
14 had different views or comments on each letter.

15 COMMISSIONER YAKI: Okay, no problem. I
16 just wanted to comment on Commissioner Kirsanow, and
17 just say that we B- I knew that there=s more than a
18 passing resemblance in his balding head to the Grinch.

14 draft letter to everyone. There was one minor change
15 that I made to that. I think you should have all gotten
16 a copy. I removed a reference to a blog post which I
17 just thought is kind of out of place with the other types
18 of recognitions that we were outlining. But other than
19 that, the letter remains the same as circulated before.
20 Discussion?

2 revisions but I'm afraid that they arrived a little bit
3 too late B-

4 CHAIRMAN CASTRO: Oh.

5 COMMISSIONER YAKI: B- to clean up a
6 little bit of the inconsistencies in the language C-

7 CHAIRMAN CASTRO: Okay.

8 COMMISSIONER YAKI: B- with regard to the
9 description of the town, and also to take reference to
10 my mom. So, I think you might B- if we could approve
11 this with B-

12 CHAIRMAN CASTRO: Yes.

13 COMMISSIONER YAKI: B- leave to make
14 minor technical corrections, I would like to make that
15 motion because it just B-

16 CHAIRMAN CASTRO: Yes, you're right. There

2 that I ran this by the Japanese American Citizens League
3 who is very appreciative of this effort, and just from
4 my own point of view having had the privilege of meeting
5 Fred Korematsu in the latter years of his life, it=s
6 B- we are B- I agree with Commissioner Kirsanow in
7 terms of the names of the individuals that he has spoken
8 about, but in terms of if you can find someone who had
9 a significant impact on a single discrete community,
10 notwithstanding the fact that his efforts have
11 ratifications far beyond that. But in terms of the
12 Japanese American B- indeed, the Asian American
13 community whose isolation, persecution and treatment
14 certainly in the country, and certainly in California
15 in the first half of the 20th century where they passed
16 laws denying the ability of Asian Americans to own land
17 to stop them from being farmers when they could not own
18 property. It=s the first case to talk B- to decide the
19 Equal Protection clause in America was because of an
20 anti-Chinese ordinance passed by, of all people, the
21 Board of Supervisors of San Francisco in the 1800s. Fred
22 Korematsu stands as a giant among all these for a very
23 simple, as you described it, and we describe in our
24 letter, Mr. Chairman, very simple act of courage and
25 civil disobedience in saying I don=t B- I am a loyal

1 American. I have no idea why I should be B- I and my
2 family and my friends should be shipped off to converted
3 horse stables which is what they were in California,
4 horse racing facility the Japanese Americans were
5 basically housed in the horse stables before they were
6 transited out to different parts of the country. And
7 he said, you know, I am an American, I=m going to act
8 like an American. I want to be treated like an American.

9 And I would just note as a matter of
10 constitutional jurisprudence that notwithstanding the
11 fact that Writ of Coram Nobis taken by a group of young
12 dynamic Japanese American and Asian American attorneys
13 led by my friend, Dale Minamis, Karen Kai, and so many
14 others, had finally forced the government to admit that
15 they, indeed, not only had no evidence that there was
16 a Japanese fifth column on the west coast, but to the
17 contrary they found affirmative findings that there
18 were none, and it was a very loyal and patriotic
19 community. Notwithstanding that in one of the most
20 shameful decisions by Earl Warren and by President
21 Franklin D. Roosevelt, over 100,000 Japanese American
22 men, women, and children were sent into isolation in
23 internment camps supposedly for their own protection,
24 except for the fact that the machine guns were all
25 pointed on the inside, not on the outside. And Fred

1 Korematsu said this is wrong. What is B- I B- and he
2 stood as a symbol of civil disobedience and courage for
3 all members of the Japanese American community, for
4 sure.

5 And I would just like to say that one of
6 the stains on the Constitution, constitutional law of
7 which there are, unfortunately, several, Plessy being
8 one of them. Korematsu, notwithstanding the fact that
9 his conviction, personal conviction was overturned,
10 the decision, Korematsu v. United States still remains,
11 unfortunately, the law, part of the constitutional
12 jurisprudence of this country. And I would just say that
13 during the constitutional arguments over the detention
14 center in Guantanamo, in one of the briefs used by the
15 then Solicitor General of the United States, Korematsu
16 was cited for the purpose of justifying the detention
17 center at Gitmo. So, while Fred Korematsu was
18 personally vindicated and stands as a shining example
19 of courage and civil disobedience and principle, the
20 decision itself still remains, and hopefully will
21 become a footnote and never be used again. But the mere
22 fact that it is there to justify the incarceration of
23 people deemed to be enemies of the State even if they
24 are citizens is a B- should be a sobering warning to
25 all of us who care about, are concerned about civil

1 rights and civil liberties. But in that vein, again,
2 Mr. Chairman, thank you for your leadership, and I hope
3 this B- the President takes positive action on this and
4 on the Cesar Chavez resolution that this Commission
5 will be forwarding.

6 CHAIRMAN CASTRO: Thank you, Commissioner
7 Yaki.

8 COMMISSIONER YAKI: Thank you.

9 CHAIRMAN CASTRO: Actually, I've been
10 informed by Special Assistant that the copy of the
11 letter that was circulated this morning to everybody
12 is the correct version with your corrections. I think
13 perhaps maybe it might not have been emailed to you,
14 but your corrections were made on the draft.

16 CHAIRMAN CASTRO: So, with that I would
17 B- are there other questions or comments on this? If
18 not, I will call this vote for question, call this
19 question for vote.

1 of what Commissioner Yaki had to say, but I think he
2 said it very well, articulately, and in an impassioned
3 fashion. And I, as I said before, would oppose a
4 national holiday but would support some meaningful
5 commemoration of Mr. Korematsu.

6 It was a significant act on his part. I
7 think that there=s insufficient attention, and I have
8 said so a number of times to the manifold and long-time
9 acts of discrimination against Asian Americans. And I
10 don=t like using that term because I think it=s somewhat
11 ham-handed, but a lot of racists like to seem to lump
12 people into a particular category, and that=s the
13 category very often that they like to lump them into,
14 but they=ve discriminated against Asian Americans
15 since the outset of our country. So, as someone who also
16 has had family members in detention camps and
17 brutalized therein, including my own father, but in a
18 nation where you might expect it, this is something that
19 is of great importance. I just do not think it should
20 a national holiday.

21 CHAIRMAN CASTRO: Thank you, Commissioner.
22 Any other comments? If not, I=m going to call the motion
23 for vote. Commissioner Kirsanow, how do you vote?

1 we were scheduled to have our Stand-Your-Ground
2 briefing, and one of the topics they=re going to be

4 New York City. So, the main folks that we would have
5 loved to have had at our meeting will not be available
6 on April 11th, so that is why that was put on the agenda.
7 And then the next question was if we move the
8 Stand-Your-Ground, should we also move the Sexual
9 Harassment? And in discussing it with Commissioner
10 Heriot, she was amenable to possibly pushing it
11 forward, if necessary.

12 CHAIRMAN CASTRO: So, do you have a
13 particular proposal in terms of B-

14 MS. SALLO: The thought had been to
15 reschedule the Stand-Your-Ground for May, and then do
16 the Sexual Harassment in July.

17 CHAIRMAN CASTRO: Okay. And folks know from
18 email that I issued previous to this meeting that we
19 are going to do the Stand-Your-Ground briefing in
20 Florida.

3 so they can=t be present. And then Ilya has indicated
4 he=s not available April or May either, so that=s where
5 we stand right now. So, I=m B- obviously, this is
6 Commissioner Yaki=s Concept Paper, and he, obviously,
7 would have a voice in this, but I=m amenable to whatever
8 the Commissioners feel is best to accommodate. But
9 definitely April 11th won=t work because even the
10 researchers that we needed to be present at the briefing
11 are not available in the month of April.

12 CHAIRMAN CASTRO: Commissioner Yaki, can
13 you give us your thoughts?

14 COMMISSIONER YAKI: Yes, I am in no hurry
15 to get this B- to do this if it means B- if it=s at the
16 cost of giving the witnesses amenable locations, et

8 Commissioner Achtenberg, then Commissioner Heriot,
9 then Commissioner Kladney. Okay.

10 COMMISSIONER ACHTENBERG: All I would ask
11 is that individual calendars be taken into account
12 because it=s B- and we try to accommodate B- find a date
13 that all Commissioners can be accommodated.

14 CHAIRMAN CASTRO: Right. I know some folks
15 will be out of the country.

16 COMMISSIONER ACHTENBERG: Yes because, I
17 mean, this is a real problem for us now that the State
18 legislatures B-

1 prospect of CIR seems less likely every day. My concern
2 is that should immigration reform in some format not
3 pass, and I think we see this already beginning to
4 happen in some states, a resurgence of the state
5 enforcement type of actions focused on undocumented
6 immigrants because there is a lack of federal action,
7 I think the data that we collected again on both sides
8 of the issue which is out there should be turned into
9 a report. And knowing that it=s going to take some time
10 to issue that report, I want to begin that process now
11 so that we can actually benefit from the work that was
12 done by this Commission and contribute to the public
13 policy debate which will be continuing both at the State
14 and I believe at the Federal level. So, that is why I=m
15 bringing this to you all for a vote. So, is there B- I
16 guess I=ll make that my motion. Is there a second?

1 in time for any debate. We see that the debate has gone
2 on for quite some time, whenever you have a one part
3 of Congress controlled by one party and another by
4 another party, there is going to be protracted debate
5 on almost everything including what to have for lunch.

7 We voted unanimously pursuant to an
8 agreement that was struck between Commissioner Gaziano
9 and the Chair. The prelude to such agreement was that
10 Commissioner Gaziano would assist in securing a
11 balanced panel of witnesses, because there were a
12 number of witnesses who were reluctant to appear for
13 a variety of reasons. And those witnesses appeared at
14 the instance of Commissioner Gaziano provided they
15 wouldn't be defamed or slandered, and had Commissioner
16 Gaziano I know, and Commissioner Heriot, myself and
17 Vice Chair not cooperate in that agreement, there would
18 be no quorum for the briefing, there would have been
19 no report and no briefing on immigration back in August
20 of 2013, or 2012. Yet, the briefing went forward. The
21 witnesses nonetheless several of them were defamed as
22 racists, xenophobes, likened to the Klan, and when a
23 vote on the matter came up last March, four
24 Commissioners were opposed to it, Gaziano, Heriot,
25 Kirsanow, and Vice Chair Thernstrom. But, nonetheless,

5 issues. Now Gaziano and Thernstrom are not here, but
6 nonetheless I think we should stick by the previous
7 vote. It was an understanding as to why that vote went
8 forward. And I know you=ve got the votes to go forward
9 with this if you want to, but if any media make any
10 reference to the report without noting how it came to
11 be it will be woefully complicit promoting the
12 continued defamation of these witnesses, and I will
13 make sure at least in my capacity to correct the record
14 every single chance I get.

15 CHAIRMAN CASTRO: Thank you, Commissioner
16 Kirsanow. First of all, as I indicated to you in our
17 email exchange of last night, I think there=s a lot of
18 inaccuracies in that statement which I know you base
19 it on correspondence that you received from former

22 routinely seem to misunderstand one another. And I
23 think you=re mixing two different issues.

5 to be one-to-one. And there was a dispute about my
6 having added a speaker from the Southern Poverty Law
7 Center.

8 There was no discussion at that time
9 whatsoever about the issue of a transcript versus a
10 report. That issue did not come up until much later.
11 And there certainly was no specific agreement between
12 myself and Commissioner Gaziano for any vote in
13 exchange for anything else. In fact, I very clearly told
14 him that he could vote however he wanted on other
15 issues.

16 I've explained to you why I was motivated
17 to move this as a transcript. I know you've indicated
18 in your email to me that Commissioner Gaziano felt that
19 the transcript, the hearing itself was inappropriate.
20 If that was the case, why do we even put the transcript
21 up on the website.

22 There was no defamation that occurred. We
23 had our OGC look at that issue left and right. The
24 statements that were drafted that were of some concern,

5 was not included. So, there is no defamation at all in
6 that transcript. That transcript has passed muster in
7 terms of being appropriate. And it was always my
8 understanding, perhaps not his, but it was always my
9 understanding that this issue could be revisited again.
10 And I am revisiting it, for the reasons I've stated.

11 COMMISSIONER KIRSANOW: Mr. Chair, I have
12 no objection to revisiting the issue in a new briefing.
13 If you want to have another briefing, fine. I don't have
14 any objections to that. But with respect to this
15 particular briefing and any report that therefrom,
16 we've had a vote on this. There is an understanding that
17 wasn't just the understanding of Commissioner Gaziano.
18 I was present throughout everything other than your
19 private conversations with him, and I had a distinct
20 understanding as to why it is we posted a transcript
21 as opposed to having a report.

5 at Vassar in August, so I=d like to say it=s been a
6 pleasure having Nicholas here with us, and I welcome
7 Ryan as he commences his internship today.

8 CHAIRMAN CASTRO: Thank you for your work,
9 and thank you in advance for the work you=re going to
10 do. Appreciate it. In fact, would you like to draft a
11 briefing report on immigration?

24 2006. They=re also going to follow-up on how well the
25 Commission has implemented GAO=s prior

1 recommendations. And, finally, they will be looking at
2 the role of the State Advisory Committees in
3 accomplishing the mission of the Commission, so I will
4 be their point person, and I will be providing them with
5 any and all documents that they wish to review. And they
6 will probably be here for about three months once B- and
7 I don=t know yet when they=re going to come in, but it
8 will be as soon as possible.

9 Finally, I have some good news. As you
10 know, we just finished a CFC campaign, so I wanted to
11 B-

21 highest award. We actually received the President=s
22 award signed by President Obama.

8 achieve a 3 percent increase in total dollars raised
9 over the previous year=s campaign. Our Commission had
10 an almost 50 percent increase in total dollars raised.
11 We also increased the participation from last year=s
12 campaign earning the Participation Achievement award.
