North Carolina Advisory Committee to the U.S. Commission on Civil Rights Continues Study on Civil Rights and Equity of Legal Financial Obligations and Announces March 2022 Public Meeting

The North Carolina Advisory Committee to the U.S. Commission on Civil Rights will convene a public meeting – via webinar – examining civil rights and equity in legal financial obligations (LFOs). This will be a continuation of the study that was initiated by the advisory committee in 2020 and is part of a new series of briefings that began in February 2022 when the Advisory Committee heard from judicial system practitioners, including judges and a district attorney.

The scope of this project lies in examining the impact of LFOs on the basis of race, color and income and whether LFOs have a disparate impact on minority and indigent groups. The focus for this project will be post-conviction LFOs.

Chair Olga Morgan Wright said: "The North Carolina Advisory Committee looks forward to our continued examination with experts and practitioners as to whether Legal Final Obligations have a disparate impact on minority and indigent populations in North Carolina. The Committee will consider their testimony, for inclusion into our report, as our project develops. *We welcome Public Comments and Written Testimony from All Interested and Affected North Carolinians to this public meeting*."
