South Dakota Advisory Committee to the U. S. Commission on Civil Rights Announces Public Web Briefings on Voting Rights and Voter Access

The South Dakota Advisory Committee to the U.S. Commission on Civil Rights is hosting a series of online public panel briefings to hear testimony regarding the potential civil rights concerns related to voting rights and voter access in South Dakota. Committee Chair Travis L. Letellier said, "Our Committee is very interested in listening to the experiences of people across South Dakota who may have faced barriers when participating in the voting process. One of the primary purposes of the State Advisory Committee is to ensure that people have access to voting and that barriers to voting are identified and mitigated. We will hold a series of public hearings during the summer and fall of 2022, and we will hopefully hear from our Tribal communities, New Americans, and people with a variety of physical abilities and disabilities who are willing to share their stories with us. Ultimately, the State Advisory Committee hopes to offer a series of practical recommendations to Tribal, Federal, and State authorities detailing where barriers to voting are occurring in South Dakota and how, possibly, to eliminate them."
