## The Puerto Rico Advisory Committee to the United States Commission on Civil Rights to Host Virtual Panel as Part of its Study on the Insular Cases and Makes Call for Public Participation

The Puerto Rico Advisory Committee to the U.S. Commission on Civil Rights (USCCR) will host a virtual panel with a focus on the economy and the Uniformity Clause as part of its study titled "The Insular Cases and the Unincorporated Territory Doctrine and its Effect in the Civil Rights of the Residents of Puerto Rico." The event will include testimony from various economists and experts on this topic. This virtual panel is a continuation of the public briefing held by the Committee in May 2023 and is part of the general overview phase of this project.

The Committee Chair, Andrés Córdova Phelps, said: "The Committee has decided to receive additional testimony in order to obtain a more complete understanding of how the Insular Cases impact the residents of Puerto Rico. After first hearing from legal experts, community groups, and academics on the subject, we are now going to focus on the economic perspective, specifically the connection between the Insular Cases and the fiscal and tax situation in Puerto Rico, with special emphasis on the Uniformity Clause. We invite members of the public who are interested in attending to share their perspectives during the public comment section of the event."

Members of the public will be invited to share their comments during an open comment period at the end of the briefing.
