Colorado Advisory Committee to the U.S. Commission on Civil Rights Invites the Public to Participate in a Series of Virtual Panels Examining Allegations of Antisemitism on the Auraria Campus at Three Colleges and Universities

The Colorado Advisory Committee (Committee) will continue to hold a series of public online briefings and a community forum until September. The purpose of these events is to hear testimony examining the presence and/or absence of antisemitism at Colorado universities and colleges, specifically at the Auraria Campus in Denver that hosts the Community College of Denver, Metropolitan State University of Denver, and University of Colorado Denver. During their first briefing, the Committee heard from experts examining First Amendment Rights and campus protests; and challenges enforcing Title VI in the current context. In the next two months, the Committee will hear from student groups, impacted individuals, and administrators representing the universities and colleges at the center of the Committee's inquiry.
