- Does anyone else have any announcements?

- If not, let's go to the Staff Director's
- 5 Report. Any questions or discussion on the Staff
- 6 Director's Report?
- 7 Yes, Commissioner Lee.
- 8 COMMISSIONER LEE: Madam Chair, I have a
- 9 couple of questions on a couple of the SAC activities.
- 10 But given today's time, I'd like to reserve bringing
- 11 that up on the next Commission hearing.
- 12 CHAIRPERSON BERRY: I'm having trouble
- 13 hearing.
- 14 COMMISSIONER GEORGE: Yes. Could
- 15 Commissioner Lee's microphone be turned up?
- 16 COMMISSIONER LEE: I have a couple of
- 17 questions regarding two SACs and two of the reports.
- 18 But given today's time, I'd like to reserve asking them
- 19 at the next Commission meeting if I may, regarding
- 20 Maryland and New Hampshire.
- 21 CHAIRPERSON BERRY: Okay. So you want to ask
- 22 questions, informational questions, but you'll do it at
- 23 another meeting. Okay. Fine.
- 24 Any other questions or comments on the Staff
- 25 Director's Report?

- 1 (No response.)
- 2 It might be appropriate for us to say at this
- 3 point that a major item that we have before us, and
- 4 actually the only major item under the Staff Director's
- 5 Report is what the Commission will do about holding a
- 6 third hearing.
- 7 As I understand it from the Staff Director,
- 8 the time has passed for a notice, 30-day notice for
- 9 hearings in July and whatever date it was that we had
- 10 talked about earlier.
- The last time, as I recall, we said that we
- 12 would get a memo from the staff explaining what we
- 13 could do in Seattle if we went there and that memo, I
- 14 guess, was circulated yesterday, to my knowledge or was
- 15 attempted to be circulated, one or the other. I'm not
- 16 sure.
- Do we have a memo? When I say we --
- 18 Commissioners.
- 19 COMMISSIONER HORNER: We were traveling here
- 20 yesterday.
- 21 CHAIRPERSON BERRY: Right. And so what is
- 22 the status of this? Do you need a decision on that or
- 23 what's the status of this, Staff Director?
- 24 STAFF DIRECTOR MOY: Well, Madam Chair, at
- 25 this time I know how important it is to have another

- 1 Schools and Religion hearing, but given the
- 2 difficulties that we have had and also the fact that we
- 3 need a 30-day notice for the Federal Register, plus the
- 4 pressure that staff has been put under not only because
- 5 our Office of General Counsel has had two vacancies
- 6 that have not been filled, plus one more recently, and
- 7 having to put together this hearing as well, I just
- 8 don't feel that we can comfortably do another one at
- 9 this time.
- 10 CHAIRPERSON BERRY: So we have to make a
- 11 decision. That is, we Commissioners, about how we want
- 12 to instruct you concerning a third hearing; that is,
- 13 when, where, what, how and why.
- 14 I understand from you, Staff Director, that
- 15 three of the people in the Office of General Counsel
- 16 have gone on to higher and better things, and so we're
- 17 happy for them. We're not happy for us. We're glad to
- 18 have been a training ground for them.
- 19 So, we need to have just a brief discussion
- 20 so we can give some interim guidance or some kind of
- 21 quidance to the staff concerning this. And do we want
- 22 to wait until we get the memo and then have a
- 23 conference call or do we want to wait and decide it in
- 24 July, understanding that obviously we're not going to
- 25 have a hearing in July, or what is the wish of

- 1 Commissioners on this subject.
- 2 Commissioner George.
- 3 COMMISSIONER GEORGE: Madam Chairman, will we
- 4 be getting the memo? I just didn't hear the Staff
- 5 Director's comment about the date. We'll be getting
- 6 the memo this week, this coming week, I mean?
- 7 STAFF DIRECTOR MOY: Yes.
- 8 COMMISSIONER GEORGE: I think in view of
- 9 that, perhaps what we could do is arrange for a
- 10 telephone conference once we've had a few days to look
- 11 over the memo and then at that conference we might very
- 12 well decide to put off any decision until the next
- 13 meeting.
- But I think, if possible, we should at least
- 15 confer by telephone among the Commissioners once we've
- 16 had an opportunity to look at the memo.
- 17 CHAIRPERSON BERRY: What do others -- any
- 18 other comments? Any different views or any other
- 19 advice anyone wants to suggest on this subject or
- 20 should we simply go with Commissioner George's
- 21 suggestion?
- VICE CHAIRPERSON REYNOSO: Madam Chair, I
- 23 think that would be satisfactory. Let's get the memo
- 24 and then we can talk.
- 25 CHAIRPERSON BERRY: Okay. Staff Director
