# Louisiana Advisory Committee to the U. S. Commission on Civil Rights Announces Series of Public Meetings: Civil Rights and Barriers to Voting

Baton Rouge, Louisiana – On November 15, the Louisiana Advisory Committee to U.S. Commission on Civil Rights will convene the first of a series of public meetings to examine barriers to voting that may have a discriminatory impact based on race, color, disability status, national origin, and/or the administration of justice.

The November 15 public session will be held at the School of Nursing Auditorium, Grambling State University, One Cole Street, Grambling, LA. The Committee will hear testimony from academics, policy makers, community groups, and other interested individuals. Members of the public will be invited to speak during the open forum session, 12:00 pm to 1:00 pm. Persons with disabilities requiring reasonable accommodations should contact the Midwest Regional Office prior to the meeting. The Committee will also accept written testimony submitted to dbarreras@usccr.gov by December 31, 2017.

Committee Chair Robert Lancaster stated: "Citizens' free exercise of the right to vote is fundamental to a functioning democracy. The Louisiana State Advisory Committee unanimously identified the importance of this right in selecting to investigate any barriers to voting in Louisiana that impede on any eligible voter's ability to cast his or her vote. Through the collection of testimony, the Committee hopes to understand what barriers to voting, if any, exist in Louisiana; produce a report helpful to the U.S. Commission on Civil Rights for its national review of voting rights; and to inform Louisiana citizens and policy makers working to ensure no one in Louisiana experiences any unreasonable impediments in exercising the right to vote."
