U.S. Commission on Civil Rights Public Briefing:

In the Name of Hate: Examining the Federal Government's Role in Responding to Hate Crimes

Washington, DC – On Friday, May 11, in Washington, DC, the U.S. Commission on Civil Rights will hold a public briefing on hate crimes and bias-related incidents in our local communities and schools. The Commission will hear from law enforcement experts, state and federal policy makers, and the public about the federal and local responses to these heinous acts. The briefing will focus on three key areas: reporting practices, investigations and prosecutions, and prevention efforts.

The public will have an opportunity to address the Commission during an open comment session – please see full details <u>here</u>. The briefing will also be <u>live-streamed</u>. We will also accept written materials for consideration; please submit to <u>HateCrimes@usccr.gov</u> no later than June 11, 2018.

Subsequent to the briefing, the Commission will issue a report that will discuss effective responsive and preventive actions and offer recommendations for improved practices.

In a unanimous Commission <u>statement</u> last year in in response to the attacks in Charlottesville, Virginia, Chair Catherine E. Lhamon stated that "every American deserves to live confident in the expectation that his or her equal dignity will be respected and receive protection from government agencies." The Chair also noted that violence and hate driven by animus against anyone for who they are — whether on the basis of race, color, religion, sex, sexual orientation, gender identity, age, disability, or national origin — "degrades our nation."
