### Illinois Advisory Committee to the U. S. Commission on Civil Rights Announces Briefing on Fair Housing and Calls for Public Comment

On May 3, 2019, in Chicago, the Illinois Advisory Committee to the U.S. Commission on Civil Rights will host a public briefing on fair housing issues in the state. The Committee will examine the extent to which Illinois residents have fair and equal access to housing without regard to race, color, disability status, national origin, age, religion and/or sex. The Committee will hear testimony on a range fair housing-related issues, including the enforcement of civil rights complaints, affordable housing development, housing conditions, and discrimination in the sale or leasing of residential property.
