In December 2018, the U.S. Commission on Civil Rights released <u>Broken Promises: Continuing Federal Funding Shortfall for Native Americans</u>, which evaluated whether the federal government is meeting its trust responsibilities, and examines budgets and spending of federal agencies that sponsor Native American and Native Hawaiian programs, including the Departments of Health and Human Services, Interior, Housing and Urban Development, Justice, and Education.
