## New York Advisory Committee to the U. S. Commission on Civil Rights Announces Briefings on Equity in Education Funding in New York

On June 12 and 13, 2019, in Long Island City, the New York Advisory Committee to the U.S. Commission on Civil Rights will host public briefings on education equity in the state. The Committee will examine the extent to which New York's education financing impermissibly discriminates against students of color.

Committee Chair Alexandra Korry said, "Educational opportunity is the foundation for an equitable society. All our children should be provided with the resources necessary to become functioning participants in our civil discourse. That is the law of the State. The Committee's briefing seeks to better understand whether New York State's approach to education financing, including the Foundation Aid formula and its various add-ons, has the effect of discriminating against students of color."

As part of this study, the Committee invites members of the public to submit written comments on their perspectives or experiences with education equity issues in New York.
