The Impact of Immigration Enforcement on California Children

The California Advisory Committee to the U. S. Commission on Civil Rights is hosting a public meeting to hear testimony regarding federal immigration enforcement impacting the state’s children. The Committee will examine the impact of U.S. Immigration & Customs Enforcement (ICE) enforcement practices on access to public education for California K-12 students; access to equal protection under the law for individuals based on their perceived national origin; and the extent to which due process is denied to K-12 students and their families.
