## California Advisory Committee to the U.S. Commission on Civil Rights Public Briefing: *Immigration Enforcement Impacting California Children*

On October 16, 2019, in Los Angeles, the California Advisory Committee to the U.S. Commission on Civil Rights will host a public briefing to gather testimony on immigration enforcement impacting California children. Among related concerns, the Committee will receive testimony on the impact of U.S. Immigration and Customs Enforcement (ICE) enforcement practices on access to public education for California's K-12 students; access to equal protection under the law for individuals based on their perceived national origin; and the extent to which due process is denied to students and their families.

Following the meeting, the Committee will issue its findings and recommendations in a report to the Commission.

Brian Moriguchi, Vice Chair of the Committee, stated: "ICE enforcement has been widely viewed as a national issue, but its impact is felt at the local level. We want to have an open and safe discussion regarding the impact of ICE enforcement on California communities and welcome public participation at our briefing."
