Are Rights a Reality? Evaluating Federal Civil Rights Enforcement

Thursday, November 21, 2019, 10:45 am ET

On November 21, U.S. Commission on Civil Rights Chair Catherine E. Lhamon will hold a public conference call on the Commission's forthcoming report, *Are Rights a Reality? Evaluating Federal Civil Rights Enforcement*, which examines federal government civil rights enforcement efforts in Fiscal Years 2016 through 2018. With this evaluation, the Commission fulfills its critical statutory charge to report on the effectiveness of federal civil rights enforcement. The Commission asked: what are the key elements for effective civil rights enforcement? Do federal agencies have sufficient resources to fulfill their enforcement responsibilities? And, most importantly, is the federal government satisfying its obligation to the American people to protect and vindicate their civil rights across the justice system and other issue areas, such as education, employment, healthcare, housing, and immigration?

Are Rights a Reality?, based on expert and public input, and research and analysis, will offer actionable recommendations to the President, Congress, and numerous federal agencies. The report will be available on our <u>website</u> on the day of the conference call.
